## **Description of the current workplace / healthcare centre**

The specialist care of Adult Psychiatry is conducted by the Southern Division of Kalmar County, with the capital in Kalmar. The work is conducted both in in-patient and in out-patient care and in treatment units. Activity today includes 3 inpatient care departments, one emergency reception, 3 outpatient care surgeries and 3 treatment units with focus on psychiatric rehabilitation, addiction and self-harm (DBT).

The clinic is undergoing a restructuring in which we revise care processes and organization. This takes place for being able to move to a completely new and more appropriate psychiatry building, which is expected to be completed in late 2021.

We conduct systematic quality work, including marker-based medical record review, in order to continuously develop psychiatric care.

For those who come to us there are several opportunities to find a suitable place / role on the basis of special interests and skills.

## **Number of employees and occupational categories**

Approximately 230 employees in various professions: nurse, social worker, welfare officer, psychologist. We have 10 permanent doctors and trainees.

## **Job description**

Specialist in General /Adult Psychiatry with experience both in outpatient and whole day care. The goal is that the candidate will reach competency in on-call duty in Sweden, i.e. will be able to become a part of oncall shift.

## **Training requirements**

Legitimated doctor with specialty in General / Adult Psychiatry.

## **Experience required**

Experience as specialist in Adult Psychiatry.

## **Competences and skills which are especially important for position**

Good language skills, social competence, interest in and ability to work both independently and in multidisciplinary team.

## **Preparedness and duty-service**

Included in the service according to a specified scheme.

## **Other requirements**

Appraised personal suitability is heavily weighted.

## **Salary**

In case of employment months 1- 6: 45.000 SEK / month, 7- 12: 55.000 SEK / month and after one year individual rating (in general 60-80.000 SEK or even more).

## **Services offered by the Employer and Partners**

- During the personal visit which is part of the interview process, the cost of travel and accommodation is financed by Mediflexible
- 6 months long, free Swedish course, financial support during the course (the amount is topic of negotiation)
- Possibility of free language education for family members – depends on individual agreement
- Informal help during the application for Swedish license to practice, supervision of the process
- 2 days long free Swedish legal and social training
- Integration assistance (assistance in registering at tax authority, opening bank account, etc.)
- Assistance in the organization of moving and in apartment-seeking

- Professional English CV in which your experience (number of completed examinations/surgeries, with differentiation between pre-and post-specialization experience) are detailed
- scanned version of license to practice in home country with English translation (no official needed)
- scanned version of medical and specialist certificates with English translation (no official needed)
